APPLICATION INSTRUCTIONS

SUBSTRATE QUALITY / PRE-TREATMENT

Concrete surface must be free from surface water. Evaporation of the surface water can take from 30 mins to 2 hours, depending on temperature and water/ cement ratio.

APPLICATION

Stir thoroughly before use to ensure full dispersion of solids.

Spray product in a fine mist to completely cover the concrete surface. Maintain the pressure in the application equipment to ensure a consistent spray.
